#### B. Call the Meeting to Order

#### A. Bylaws

Jeff Whitmore presented the updated Bylaws to the committee, highlighting revisions made in collaboration with legal counsel and BoardOnTrack. Key updates include clarifying language by changing "Trustees to begin term" to "term begins on," adjusting the minimum number of required Board meetings to eight, and moving the information on remote participation to its own dedicated section.

Toyuwa Newton made a motion to recommend the draft bylaw amendments to the full Board of Trustees at the February Board meeting.

Steve Palmer seconded the motion.

The committee **VOTED** unanimously to approve the motion.

#### **B.** Trustee Recruitment

The discussion then transitioned to Trustee Recruitment. Jeff Whitmore provided an update on Kara McLaughlin's conversation with Latinos for Education. The committee will continue identifying potential trustee candidates before the March 31st deadline, focusing on individuals with expertise in HR, legal, and commercial real estate.

#### C. BoardOnTrack Implementation

Fallon Burke reviews the BoardOnTrack platform with the committee and reminded members to login to make sure they have access.

Jeff reminded the committee to complete the MCPSA Board Self-Assessment before the end of the day.
